

# Installation and Operation Instructions DeltaLED R65\* LED Beacon

The DeltaLED R65 LED Beacon features 12 powerful LED's arranged to produce a 360° flash pattern, with a flash rate of 125FPM for maximum visibility, with additional features including multiple flash patterns. This Beacon is suitable for applications where the UK lighting regulation Chapter 8 is a requirement\*. Combining the solid state, maintenance free and long life nature of LED technology with a proven tough housing design. This ECCO Safety Group, beacon is designed to maximise resilience to excessive vibration and increase the life of the product.

### Wires:

RED: = +VE (10-36V DC)

BLACK: = GND

YELLOW: = (Pattern Select, Synchronisation and Reset) – Momentarily Connect to GND to cycle one by one through the flash patterns. The patterns have Phase A and B. Connect all Yellow wires with units programmed in Phase A and they will synchronise (up to 4 Beacons). Connect beacons programmed in Phase A and B and the units will flash alternately. Connect to GND for 5 seconds and the flash pattern will be reset do default Double flashes pattern 4.

### **3 BOLT FIXING VERSION**

## TO ENSURE A WEATHERPROOF INSTALLATION THE BEACON MUST BE FITTED WITH THE SUPPLIED GASKET AND MOUNTED ON A FLAT PANEL OR SURFACE FORMING PART OF A WEATHERPROOF ENCLOSURE.

Drill the panel or surface to accept the wires and the 3 M6 screws (see figure 1).

Connect the 2 wires to an appropriate power source ensuring that the RED wire is connected to the POSITIVE terminal of the supply via a suitable 3A fuse.

Fit the fibre washers under the screw heads to prevent water ing ress and fix using the shakeproof washers and nuts. The rubber grommet supplied may be used to protect the wires when the beacon is panel mounted. The grommet is designed to fit a hole 6mm dia with panel thickness of 1.5-2mm.

### **SINGLE BOLT FIXING VERSION**

### TO ENSURE A WEATHERPROOF INSTALLATION THE BEACON MUST BE FITTED WITH THE SUPPLIED GASKET AND MOUNTED ON A FLAT PANEL OR SURFACE.

Drill the panel or surface to accept the M12 threaded bush.

Fit the beacon in the required position, first passing the wires and bush through the pre-drilled hole. Secure using the M12 half nut and washer supplied.

Connect the 2 wires to an appropriate power source ensuring that the RED wire is connected to the POSITIVE terminal of the supply via a suitable 3A fuse.

### **MAGNETIC BASE VERSION**

### THE BEACON MUST BE FITTED ON A FLAT PART OF A STEEL ROOF OR PANEL.


Check that the vehicle battery voltage is compatible with the beacon to be fitted. The connection to the beacon must be fitted with a suitable 3A fuse.

Wipe the roof of the vehicle where the beacon is to be placed to remove any debris or grease, and ensure that the foam gasket is clean, dry and in good condition. Place the beacon in the required position and connect to the vehicle battery supply using the cigar plug.
